Dear Mr. Greenewald:

This is a final response to your correspondence of 28 August 2019, submitted on behalf of The Black Vault, wherein you requested an Executive Order 13526 mandatory declassification review of the following:

***All responsive documents that were reviewed in CIA case F-2014-02427. This was a referral from DIA through FOIA case 0300-2014. All responsive documents were denied due to (b)(1) and (b)(3). I ask that these records be reviewed again for possible release. The topic of the records was extra-sensory perception or ESP***

We have completed a thorough search and located material responsive to your request that we determined that one document must remain classified on the basis of Section 3.3(b)(1) of the Order. As a result, the material cannot be released in sanitized form.

We have also determined that one document may be released in sanitized form. We have deleted material that must remain classified on the basis of Section 3.3(b)(1) of the Order. Additional information must be withheld because withholding is authorized and warranted under applicable law as provided by 6.2(d) of the Order. The fact of the existence or non-existence of such records is itself currently and properly classified and is protected from disclosure by Section 6 of the CIA Act of 1949 and Section 102A (i)(1)the National Security Act of 1947. Enclosed is a copy showing our deletions and citing our exemptions.

SUMMARY: IN 1987 THE SOVIET ACADEMY OF SCIENCES AWARDED 450,000 RUBLES TO THE USSR CLINICAL IMMUNOLOGY STATE **RESEARCH** INSTITUTE TO CONDUCT **RESEARCH** ON THE EFFECTS OF DIOXIN, A COMPONENT OF AGENT ORANGE, ON THE HUMAN IMMUNE SYSTEM. FROM 1987-1988 SOME 3,000 PATIENTS UNDERWENT NONTRADITIONAL MEDICAL TREATMENT AT THE CLINICAL AND EXPERIMENTAL MEDICINE INSTITUTE; THIS TREATMENT INCLUDED THE USE OF PSYCHIC METHODS.

2. THE USSR CLINICAL IMMUNOLOGY STATE **RESEARCH** INSTITUTE (NIIKI) HAD SOME 100 EMPLOYEES WORKING IN SEVERAL DIFFERENT BUILDINGS IN NOVOSIBIRSK.

3. EACH NIIKI LABORATORY HAD TWO PERSONAL COMPUTERS (PC) -- EITHER A SOVIET-MADE ELEKTRONIKA PC OR A SOUTH KOREAN PC. NONE OF THE NIIKI LABORATORIES APPEARED TO CONDUCT TOXICOLOGY **RESEARCH** OR **RESEARCH** INTO THE EFFECTS OF VARIOUS PHOSPHORUS COMPOUNDS ON ORGANIC TISSUES. NONE OF THE NIIKI LABORATORIES APPEARED TO CONDUCT CLASSIFIED MILITARY **RESEARCH**.

4. IN 1987 THE SOVIET ACADEMY OF SCIENCES AWARDED 450,000 RUBLES TO NIIKI'S IMMUNOREGULATION LABORATORY TO CONDUCT **RESEARCH** ON THE EFFECTS OF DIOXIN, A COMPONENT OF AGENT ORANGE, ON THE HUMAN IMMUNE SYSTEM.

6. IN 1989 KONSTANTIN ((BUTEYKO)) WAS THE HEAD OF THE LABORATORY OF NONTRADITIONAL TREATMENT (LNT) AT THE CLINICAL AND EXPERIMENTAL MEDICINE INSTITUTE (IKIEM) IN NOVOSIBIRSK. SOME 3,000 PATIENTS UNDERWENT MEDICAL TREATMENT AT LNT FROM 1987 TO 1988 [REDACTED]

[REDACTED] LNT PROVIDED PATIENTS WITH A SPECIAL DIET AND REST REGIMEN. AS PART OF THE LNT APPROACH THAT BUTEYKO DEVELOPED, A MEDICAL SPECIALIST ATTEMPTED PSYCHICALLY TO TRANSMIT BIOENERGY TO PATIENTS TO ENABLE THEM TO CONTROL OR CURE ASTHMA, SINUSITIS, ALLERGIES, CHRONIC BRONCHITIS, PULMONARY INFLAMMATION, AND HEART DISEASE.

7. BUTEYKO HAD PERFECTED HIS METHOD IN THE EARLY 1980S BY CONDUCTING EXPERIMENTS WITH PATIENT VOLUNTEERS PLACED IN THE MIDDLE OF A ROOM BETWEEN TWO CONCAVE MIRRORS FIXED ON OPPOSITE WALLS. SITTING BESIDE A PATIENT VOLUNTEER, A MEDICAL SPECIALIST WOULD CONCENTRATE ON TRANSMITTING PSYCHIC ENERGY TO THE PATIENT AS WELL AS EMPATHICALLY EXPERIENCING THE PATIENT'S DISCOMFORT; LNT RESEARCHERS BELIEVED THAT THE MIRRORS FOCUSED PSYCHIC ENERGY.

8. IN THE MID-1980S IKIEM AND AN UNIDENTIFIED INSTITUTE IN LENINGRAD TOOK PART IN SEVERAL SUCCESSFUL EXTRASENSORY PERCEPTION (ESP) EXPERIMENTS. [REDACTED] SOVIET ACADEMICIAN FNU ((KAZNACHEYEV)), A WELL-KNOWN AUTHORITY ON ESP WHO WAS AFFILIATED WITH IKIEM, STATED THAT VOLUNTEERS IN BOTH NOVOSIBIRSK AND LENINGRAD ATTEMPTED PSYCHICALLY TO RELAY TO ONE ANOTHER IMAGES OF GEOMETRIC SHAPES SUCH AS SQUARES OR CIRCLES. KAZNACHEYEV DID NOT STATE HOW MANY RESEARCHERS TOOK PART IN THESE EXPERIMENTS OR WHETHER THE SOVIET MILITARY EXPRESSED INTEREST IN THE RESULTS OF THESE EXPERIMENTS.
